Thank you for your letter of Feb 6. Glad to hear of your plans to join the HikaNation group in either March, April, May, or June. Now as to specifics...MEAGER! The hike leader Monty Montgomery informs us that the group should reach Damascus VA about March 20 and will probably proceed from Harpers Ferry WV to Wash D.C. during mid May.
